Descriptive Information:

All 2021 through 2024 model year Kia K5 vehicles manufactured at Kia Georgia from March 27, 2020 through January 23, 2024 equipped with a 1.6L Turbocharged Gasoline Direct Injection (T-GDI) engine.

The recall population was determined by a review of Kia vehicle production records. The vehicles subject to this recall were not produced in VIN order. Customers seeking information about their specific vehicle will be referred to Kia's Customer Care Center or their Kia dealer.

Defect / Noncompliance Description

Description of the defect or noncompliance:

The purge control system check valve which controls the direction of airflow from the charcoal canister to the engine may deteriorate over time, allowing pressurized air to flow from the intake manifold into the fuel tank. If this occurs, the fuel tank may expand and contact the hot exhaust pipe components. If the vehicle continues to be driven in this condition for a prolonged period, localized melting of the fuel tank may occur, possibly resulting in a fuel leak.

Description of Remedy
Remedy Type:
Consumer Advisories: Do Not Drive Park Outside
Description of remedy program:
All owners of the subject vehicles will be notified by first- class mail with instructions to bring their vehicles to a Kia dealer. Dealer will replace the check valve with an improved one. Dealers will also inspect the fuel tank for damage and if necessary, replace with a new one. Additionally, dealers will ensure the subject vehicles are equipped with the latest ECU software. Kia will reimburse owners for repair expenses already incurred pursuant to Kia's General Reimbursement Plan filed May 1, 2024.
How remedy component differs from recalled component:
The remedy check valve is of an improved design.
Identify how/when recall condition was corrected in production:
The condition was not corrected in production. The 2025MY K5 is not equipped with the 1.6L T-GDI engine and thus is not affected by this recall.
