Defect / Noncompliance Description

Description of the defect or noncompliance:

General Motors has decided that certain 2026 model year Chevrolet Silverado 1500, 2500, and 3500 vehicles may fail to conform to certain owner's manual content requirements of the Federal Motor Vehicle Safety Standards (FMVSS), including S12 of FMVSS No. 225, "Child restraint anchorage systems." Owner's manuals may not have been provided with these vehicles.

FMVSS1: 225 - Child restraint anchorage systems

Owners may be confused as to the safe use and operation of the vehicle, increasing the risk of injury in a crash.

Description of the cause:

Instructions for including the owner's manual in the vehicle's "dealer pack" were not properly followed at GM's assembly plant.

Chronology

On October 8, 2025, a GM customer literature employee submitted a report to GM's Speak Up For Safety (SUFS) system after a dealer report of four 2026 Chevrolet Silverado 2500 vehicles that were missing owner's manuals. GM's assembly plant determined that instructions to include the owner's manual in the dealer pack were not properly followed. On November 20, 2025, GM's Safety and Field Decision Authority decided to conduct a noncompliance recall. GM is not aware of any field incidents associated with this condition.
