Chronology

October 2025: During inspection of an unrelated topic one of the engineers observed that there were only 4 brackets being installed on Ricon wheelchair lifts. This resulted in investigation and identify any in house units and repair them. Simultaneously Ricon was notified and requested for them to analyze if 4 brackets will still ensure compliance to their strength.

November 2025: Ricon conducted internal investigation and informed Blue Bird that they cannot support compliance for lifts with only 4 brackets installed.

December 2025: Blue Bird agreed that this is a noncompliance with respect to FMVSS 404 S4.1.3
