**BASIC INFORMATION:**

KTM North America, Inc. has determined that a defect which relates to motor vehicle safety exists with certain 2022, 2023 and 2024 390 ADVENTURE motorcycles.

On certain motorcycles, water could enter the throttle (e-throttle) control unit and cause it to fail.

A loss of engine power increases the risk of a crash.

To ensure the highest level of safety, performance, reliability and customer satisfaction, it is necessary to replace the e-throttle assembly on all affected motorcycles.

Due to the replacement e-throttle assembly not being available the e-throttle assembly replacement on affected motorcycles can't be performed at this time.

Once e-throttle assemblies are available, you will receive another technical bulletin on this topic as soon as e-throttle assemblies are available to order to complete the e-throttle assembly replacement on affected motorcycles.

In the interim, KTM North America, Inc. will be notifying all registered owners of the above affected motorcycles by mail of this recall. A copy of the customer letter is included in this bulletin.

Registered owners will also be informed again by mail to contact an authorized KTM dealer to schedule the replacement of their e-throttle assembly when the part is available.
