



## **New Safety Recall Advanced Communication – 88C**

FCA US LLC (FCA US) has announced a safety recall on certain 2022 through 2024 Model Year (WS) Jeep® Wagoneer and Grand Wagoneer vehicles.

VINs identified as being involved in this campaign are currently live and searchable.  
**Stop sale is in effect for the above-identified vehicles.**

Vehicles impacted by a stop sale are eligible for reimbursement allowance through the Recall Floorplan Reimbursement Policy (RFPRP), which can be requested upon recall claim submission.

**IMPORTANT:** Some of the involved vehicles may be in dealer new vehicle inventory. Federal law requires you to complete this recall service on these vehicles before retail delivery. Violation of this requirement by a dealer could result in a civil penalty of up to \$27,874 per vehicle. Involved vehicles can be determined by using the VIP inquiry process.

### **REASON FOR THIS SAFETY RECALL**

Some of the above vehicles may have been built with a quarter window trim which may detach from the vehicle. The quarter window trim may not have been properly secured at the supplier. A quarter window trim which detaches may create a road hazard to operators and occupants of other vehicles, and can cause such vehicles to crash without prior warning.

### **SERVICE ACTION**

**FCA US will conduct a voluntary safety recall on all affected vehicles to inspect and, if necessary, replace the quarter window glass assembly.** The remedy for this condition is not currently available. Dealers will be notified of the launch of this safety recall by way of established communication methods. **This recall is estimated to launch in 1st Quarter of 2026.**

We ask that you please take the time to ensure that your personnel are aware of this communication and are prepared to execute a customer friendly process for inquiries regarding involved vehicles.

## Quarter Window Trim

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA US LLC has decided that a defect, which relates to motor vehicle safety, exists in certain [2022 through 2024 Model Year (WS) Jeep® Wagoneer and Grand Wagoneer] vehicles.

#### WHY DOES MY VEHICLE NEED REPAIRS?

The quarter window on your vehicle <sup>[1]</sup> may have been built with trim which may become detached. The quarter window trim may not have been properly secured at the supplier. **A quarter window trim which detaches may create a road hazard to operators and occupants of other vehicles and can cause such vehicles to crash without prior warning.**

#### HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

**The remedy for this condition is not currently available.** We are making every effort to finalize the remedy, and will service your vehicle free of charge (parts and labor) when the remedy is available.

FCA US LLC will contact you again, by mail, with a follow-up recall notice when the remedy is available. Once you receive your follow-up notice, simply contact your Chrysler, Jeep®, Dodge or RAM dealer right away to schedule a service appointment <sup>[2]</sup>. Additional options for your next steps are included on the left side of this notification. We appreciate your patience.

#### WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have already experienced this specific condition and have paid to have it repaired, you may visit [www.fcarecallreimbursement.com](https://www.fcarecallreimbursement.com) to submit your reimbursement request online <sup>[3]</sup>. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days. If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.
