**SUBJECT: RECALL CAMPAIGN #251003REV – THEATER SEAT FASTENER  
MAY DAMAGE PROPANE HOSE**

REV Recreation Group, Inc., on behalf of its manufacturing center located in Decatur, Indiana, is requesting your assistance in conducting a voluntary recall notification campaign in accordance with the United States National Traffic and Motor Vehicle Safety Act and the Motor Vehicle Safety Act.

REV Recreation Group, Inc. has decided that a safety defect relating to motor vehicle safety exists on certain Fleetwood Fortis and Holiday Rambler Invicta brand Class A motorhomes:

**Fleetwood Products**

Model Year(s) 2024-2026 Fortis

**Manufactured date range**

June 20, 2023 – September 15, 2025

**Holiday Rambler Products**

Model Year(s) 2024-2026 Invicta

**Manufactured date range**

June 20, 2023 – September 15, 2025

**Models:** Y & T Models with Theater Seat Option Only

We are notifying the owners of the affected vehicles in order to correct the problem outline below. Copies of the U.S. owner notification letters and Service Bulletin are attached for your information.

**WHAT IS THE PROBLEM?**

On motorhomes affected by this recall campaign, in the process of mounting the theater seat option, a fastener was installed through a bracket which may have damaged the LP hoses causing a risk of fire, injury or death

**WHAT SHOULD YOU DO?**

**Stock units must not be sold until the recall has been completed.** Owners of the above mentioned motorhomes have been asked to contact an authorized REV Recreation Group dealer to have the described defect remedied. In the event that you are contacted by a customer, please verify eligibility by referring to the serial

number range listed in the attached **Recall Service Bulletin #251003REV** prior to beginning repairs. Contact REV RV Technical Support at (800) 816-9825 for repair authorization, and REV RV Parts at (800) 509-3417 to order replacement parts for this campaign.

Once repairs have been completed according to **Recall Service Bulletin #251003REV**, have the customer sign your dealership's **Internal Repair Order**. Warranty labor claims are to be submitted electronically to REV Recreation Group. **Customers will not be charged for these repairs.**

*If you have one of these vehicles in your inventory, you will be mailed a Safety Recall Notice for that specific motorhome. **REV Recreation Group dealers are required to make repairs to stock units on dealer lots prior to sale or lease.***



**Federal Law (Section 154 of the National Highway Traffic and Motor Vehicle Safety Act) of 1966 requires that: If you have received a notice of recall or failure to comply from REV Recreation Group, Inc. or any component manufacturer, you must repair or otherwise correct the defect on vehicles remaining in your inventory according to the notification before selling or leasing the vehicles. Any vehicle lessor receiving this recall notice must forward a copy of the notice to the lessee within ten days.**

Please carefully review this entire package with your parts and service staff to familiarize them with the step-by-step procedure and implement the Voluntary Recall Campaign.
