Subject: **Safety Recall Involving Certain Caravans Equipped with
a Dometic Cooktop**

To Whom It May Concern,

This notice is sent to you in accordance with *the National Traffic and Motor Vehicle Safety Act*. Par Nado inc. (hereinafter "**Safari Condo**") has decided that a defect which relates to motor vehicle safety exists in certain 2019-2020 Alto F1743 and F2114 models equipped with a cooktop manufactured and supplied by *Dometic Corporation and/or Dometic Group AB* (hereinafter "**Dometic**"). This manufacturing defect concerns the following cooktop model:

Brand: Dometic
Model: PI8022
N° SKU: 9102302094

As a preventive measure and in accordance with applicable regulatory requirements, this notice is intended to inform you that your vehicle may have a defect that could pose a human safety risk.

The complete list of vehicles affected by this recall including their production numbers, vehicle identification numbers, model and year is attached to this notice.

As one of our dealers we hope that you will be able to help us to implement the correction for the owners of the affected vehicles. We apologize for this situation and want to assure you that, with your assistance, this condition will be corrected. Our team is available to give you the best support possible in the treatment of this recall.

1. Which vehicle is subject to the recall?

The information relating to the vehicle subject to this recall is set out below:

Brand: Alto

Models: F1743 et F2114

Years of Production: 2019 et 2020

2. Why is your vehicle subject to the recall?

Due to an alleged manufacturing defect, it appears that the aluminum supply tube of the Dometic cooktop, which connects the propane regulator valve to the burners, may crack. In such circumstances, a propane leak could occur, increasing the risk of a fire and/or explosion, when starting the burners and/or in the presence of heat, sparks, or flames, which could cause bodily injury and property damage.

3. What are the warning signs of the safety defect?

In the presence of such a defect, the user may hear a louder than normal hissing sound or smell propane odor. The flame produced by the burners may also appear lower than normal. In addition, the control knob of the cooktop may be loose or difficult to operate.

4. What corrective actions will we taken?

Safari Condo and its teams are actively working to implement a permanent and safe solution. The safety of our clients and their families remains our priority, and every effort is being made to resolve this situation definitively.

Once a corrective measure has been established, you will receive a second letter with instructions on how to implement the correction. Furthermore, once the remedy is found owners of affected vehicles will be informed and invited to make an appointment with the Safari Condo service department or an authorized dealer.

5. What should you do?

If a customer informs you of an urgent situation arising or warning signs appearing, prior to receiving the second letter confirming the implementation of a corrective measure, **it is recommended to immediately stop using the cooktop** until the potential defect has been corrected on the recreational vehicle.

WARNING – IN CASE OF PROPANE GAS ODOR

Customers must follow the procedure below:

- **Eliminate any potential sources of heat, flames, or sparks;**
- **Do not operate any electrical device or switch;**
- **Immediately shut off the gas supply at the vehicle’s propane tank(s);**
- **Open doors and windows to allow the gas to dissipate into open air; and**
- **Leave the vehicle immediately.**

While awaiting the implementation of the corrective measure, it is strongly recommended that customers apply the following preventive measures to reduce any potential safety risk:

PREVENTIVE MEASURES:

- Do not attempt to operate the cooktop subject to this recall;
- Turn off the gas supply at the propane tank (s) of your vehicle;
- Do not carry out any repairs or modifications yourself;
- Inform all occupants and users of the vehicle that they must not use the cooktop installed onboard; and
- Verify that the propane detector installed in your vehicle is functioning properly and replace it if necessary.
