In the course of continuous product monitoring and internal tests, Automobili Lamborghini S.p.A. has determined that a non-compliance defect that relates to motor vehicle safety exists in certain Urus model years 2019 to 2024.

In the affected vehicles, a combination of electrical noise, diminished shielding integrity, timing, and insufficient software robustness may cause a software error that deactivates the Top View System operation, preventing the rearview camera image from displaying. A rearview camera image that does not display reduces the driver's view behind the vehicle, increasing the risk of a crash.

For the reasons listed above, Automobili Lamborghini decided to launch a non-compliance recall campaign to update the cars involved.

This campaign is now available on LIASS and LDD.

In order to further support you in answering questions to your customers, we are attaching the FAQ (Frequently Asked Questions) form. Since these activities are extremely important, we are confident you will make every effort to ensure that the vehicles are repaired in the shortest time possible.

**IMPORTANT REMINDER: VEHICLES AFFECTED BY SAFETY & COMPLIANCE
RECALLS**

New Vehicles in Dealer Inventory: It is a violation of federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification under a sale or lease until the defect or noncompliance is remedied. By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

Pre-Owned Vehicles in Dealer Inventory: Dealers should not deliver any pre-owned vehicles in their inventory which are involved in safety or compliance recall until the defect has been remedied.

Ensure all relevant dealership personnel are aware of this notice so they are able to address customer questions. Owners of affected cars will be notified in writing.
