This is an important Safety Recall. The remedy will be performed FREE OF CHARGE to you.

**Certain 2025 Model Year Porsche 911 Vehicles
Porsche Recall ASA1 / NHTSA ID 25V-079**

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that certain specific 2025 Porsche 911 vehicles fail to conform to Federal Motor Vehicle Safety Standard No. 108, "Lamps, reflective devices, and associated equipment".

What is the issue?

Porsche recently determined that, due to a software issue, in certain rare instances the low-beam headlamps will not comply with the applicable aiming requirements. If this occurs, the headlamps may create glare to oncoming drivers, increasing the risk of a crash.

What will Porsche do?

To remedy this issue, your Porsche Center will update the affected headlamp software **at no charge to you**. The remedy will take approximately one hour to complete, but it may be necessary to make your vehicle available to your Porsche Center for a longer period of time. Your Porsche Center will arrange for alternate transportation if necessary.

What should you do?
Please contact any authorized Porsche Center to schedule an appointment to have this recall performed as soon as possible and to arrange for Porsche-provided alternate transportation, if necessary.
