REMEDY NOTICE

This notice applies to your vehicle: «Truck_VIN»

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Orange EV (OEV) has decided that certain 2023-2024 HUSK-e XP terminal trucks fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 120, "Tire selection and rims". The tires and rims installed are not sufficient for the vehicle and may increase the risk of a crash.

Our records indicate that you are the current owner of a vehicle affected by this action.

What is the Condition?

The posted rear Gross Axle Weight Rating (GAWR) on the federal placard of subject vehicles is incorrect, and the installed tires and rims may be inadequate. The tires are intended for industrial use and were not certified to meet the requirements of FMVSS 120. Because the rims have a maximum load rating of 11,025 lbs., the actual rear GAWR is less than what is posted on the vehicle's certification label.

What will Orange EV do?

Orange EV will install FMVSS 120 compliant front and rear tires and apply an updated federal placard with the correct GAWR rating **FREE OF CHARGE** to you.

What should you do?

Until your vehicle has been remedied, please follow the instructions below:

DO NOT EXCEED SPEEDS OF 25MPH AND LIMIT 5TH WHEEL PIN WEIGHT LOADS TO LESS THAN 44,000 LBS. UNTIL YOUR TRUCK IS REMEDIED!

Please contact your Regional Service Supervisor to schedule this repair.

What if you are not the owner or operator of this vehicle?

If you are a vehicle lessor, Federal Law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

If you know the current owner or operator, please forward this letter to them.
