

IMPORTANT SAFETY RECALL

NHTSA Recall No. 25V223

This notice applies to your vehicle(s) appearing on the attached list

May 2025

This notice is sent to you in accordance with the *National Traffic and Motor Vehicle Safety Act*.

Micro Bird has decided that a defect, which relates to motor vehicle safety, exists in certain 2023-2024 school vehicles built on GM chassis.

So that we can notify you of recalls affecting your vehicle(s), it is important that you inform us of any change or error in your mailing address, vehicle ownership or status. Please send the completed form at the bottom of this letter to recall@microbird.com using Address/Ownership Change in the Subject area.

In certain school vehicles equipped with supplemental suspension blades, the U-bolts holding them in place may break. If a U-bolt breaks, the pressure will no longer be evenly distributed, it can generate mechanical play and abnormal driving noises, damage nearby components or cause the axle to slip during sudden braking or acceleration. In extreme cases, the axle may detach from the chassis, causing loss of control, increasing the risk of crashing and if so, of injuries.

To complete this recall,

Locate the unit(s) in your fleet that appear on the attached List of Recalled Vehicles and contact a **Micro Bird dealer** to make an appointment to have your vehicle(s) corrected. The dealer will inspect the U-bolts and, if necessary, replace them. Visit <https://www.microbird.com/dealers> to locate a Micro Bird dealer near you.

Micro Bird Corporation will provide parts and reimburse labor to mitigate this recall, but it will be your responsibility as owner to contact a Micro Bird dealer to have the defect corrected. **We evaluate that it should take less than an hour to repair each vehicle.**

What if you have already paid for this repair?

You may be eligible to receive a reimbursement for the cost of repairs made prior to receiving this notice. You may submit your receipts by email to recall@microbird.com using **25-114-UUS Reimbursement Request** in the Subject area.

If you have leased this vehicle to another person or organization, you must forward this letter to the lessee within ten (10) days

- 4- Once you have completed or declined the recall for all your vehicles, for reimbursement, transmit the completed and signed List of Recalled Vehicles and your detailed invoice(s) to a **Micro Bird dealer**.
