Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that certain Model Year 2023–2025 GLC vehicles equipped with a panoramic sunroof fail to conform to Federal Motor Vehicle Safety Standard (“FMVSS”) No. 201u, “Occupant Protection in Interior Impact.” **Our records indicate that your vehicle is included in the affected population.**

What is the issue?



The rear roof lining damping may be too stiff, potentially failing to meet specific FMVSS 201u crash test requirements. If an unbelted rear seat occupant's head hits the rear roof lining during a crash where window airbags do not deploy, the risk of injury increases.

What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will rework the rear roof lining and C-pillar trim. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **two hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

Steps to take:



- If you have not already had your vehicle repaired for this recall, find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2025060004**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
