Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2022-2023 EQB 4MATIC vehicles. **Our records indicate that your vehicle is included in the affected population.**



What is the issue?

In early 2025 we contacted you regarding recall campaign number 25V050 and/or 25V894 to advise you of a needed software update for the high voltage battery in your EQB vehicle. MBAG found that the software update that was carried out as part of the prior recall did not remove the fire risk associated with the recall. MBAG found that on certain vehicles, the high voltage battery may fail due to an internal short circuit of a battery cell, which could lead to a vehicle fire while parked or driving.

In addition, in late 2025 you were notified of the above recall campaign number 25V487 to advise you that the bus bar in the high voltage battery may not be secured with the correct screws, which can cause the system to have a sudden loss of drive power without warning. A loss of drive power can increase the risk of a crash.

Both issues associated with the recall campaign numbers 25V050, 25V894 and 25V487 will be remedied with a replacement of the high voltage battery.

What will your Mercedes-Benz Dealer do?

An authorized Mercedes-Benz dealer will replace the high-voltage battery on the affected vehicles. **This vehicle repair will be provided at no cost to you.** Until the remedy is performed on your vehicle, **the maximum state of charge for your vehicle's high-voltage battery must not exceed 80%**. This is an important measure to help protect the high-voltage battery in your vehicle until the remedy is performed. Out of an abundance of caution, **customers are additionally advised to park their vehicles outside.** Please be advised that you may continue to drive your vehicle, provided that the maximum state of charge does not exceed 80%, and the affected vehicle(s) is parked outside when not in use.

While the repair time can be less than **7 hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.
