



**IMPORTANT SAFETY RECALL NOTICE**

October 28, 2025

RECALL NO. 2025-01

This notice applies to your Skeeter Boat/Trailer Package:  
Boat Model: xxxxxx

Hull Identification Number (HIN): xxxxxxxxxxxx

SKEETER has identified a potential defect in certain 2024–2026 Skeeter Built trailers related to the trailer ladder with handle. Our records indicate that the Skeeter Boat/Trailer Package you own has one of the affected trailers:

Vehicle Identification Number (VIN): xxxxxxxxxxxxxxxx

On these units, the trailer ladder weld may fail under normal operating conditions, which could result in the ladder breaking and potentially causing injury.

**What You Should Do:**

To correct this issue, an authorized SKEETER dealer will replace the trailer ladder **at no cost to you**. The procedure typically takes up to half an hour, although your dealer may need to keep your boat/trailer package longer based on their service schedule.

Please contact your SKEETER dealer as soon as possible to schedule this important replacement. Bring this letter with you when dropping off your unit.

**Do not use the trailer ladder until the replacement has been completed.**

If returning to the selling dealer is not feasible, any authorized SKEETER dealer can perform this service. To locate one near you, please visit the SKEETER website at [www.skeeterboats.com](http://www.skeeterboats.com) and click on Dealer Locator.

If you have had this repair performed before you received this letter, you may be entitled to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this repair. For more information, contact SKEETER Customer Service at (903) 984-0541.

Federal regulations require that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within 10 days.
