Dear Winnebago Owner:

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Winnebago has decided that certain 2019 Mirco Minni5, 2020 Minnie Plus5, 2018-2021 Minnie, and 2022 Hike 100 travel trailers fail to confirm to Federal Motor Vehicle Safety Standard No. "Tire Selection and Rims." Our records indicate that you have purchased a vehicle with the serial number which appears above.

REASON FOR THIS RECALL

On certain Winnebago vehicles the Federal Identification Label and Tire Loading Information Placed has the incorrect tire size listed. These vehicles were produced from January 12th, 2018- February 14th, 2022.

Incorrect tire size information can result in the improper replacement tire being installed, increasing the risk of crash.

WHAT WE WILL DO

On affected vehicles, Winnebago of Indiana will replace the Vehicle Certification Label and the Tire and Loading Information label with a new corrected label and installation instructions. The customers will also have the option to utilize a dealer for installation. The time necessary to complete the repair will be approximately 30 minutes. Please allow additional time for the dealer to process your vehicle. **This repair will be done at no charge to you.**

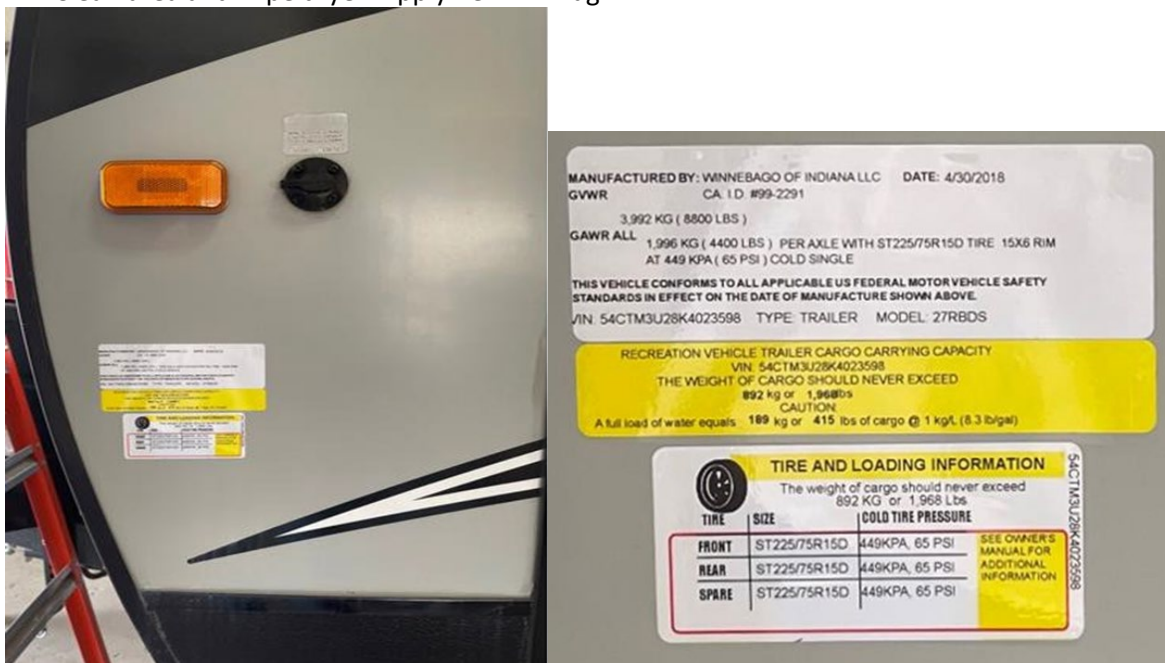
