Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2025 G-Class vehicles. **Our records indicate that your vehicle is included in the affected population.**

What is the issue?



The front short-range radar sensor printed circuit board may fail and result in a loss of autonomous partial and full braking and other driver assistance features (such as active brake assist, lane keeping assist, and DISTRONIC cruise control) without prior warning. An automatic emergency braking system that does not function as intended could increase the risk of a crash.

What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will replace the front short-range radar sensor. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **1 hour**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

Steps to take:



- If you have not already had your vehicle repaired for this recall, find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2025110002**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
