## IMPORTANT SAFETY RECALL

NHTSA Recall # 25V-774

**This notice applies to your vehicle(s), see attached VIN listing.**

Dear Valued Wabash Customer,

This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Wabash has decided that certain model year 2025 & 2026 Wabash Aluminum Step Deck Platform Trailers equipped with aluminum rear impact guards fail to conform to Federal Motor Vehicle Safety Standard No. 223, "*Rear Impact Guards*"

A complete listing of your trailers impacted by this recall is included with this letter.

### **Description of Defect:**

The rear impact guards installed on the subject trailer population may not conform to certain requirements of FMVSS 223.

### **Risk to Motor Vehicle Safety:**

Trailers equipped with a rear impact guard that does not meet the performance requirements of FMVSS 223, may increase the risk of injury in the event of a rear impact.

Wabash is not aware of any accidents or injuries related to this condition.

### **Precautions You Should Take:**

Inspection of the trailer during routine inspections required of motor carriers may identify the noncompliant rear impact guard.

### **Remedy:**

We are pleased to inform you that a remedy is available now! Wabash has designed upgraded gussets that will be added to the existing rear impact guard for FMVSS 223 compliance. The equipment listed within should be remedied as soon as practical. This repair should take approximately 5 hours and will be performed at no cost to the owner. The owner may perform this recall and be reimbursed by Wabash in accordance with our standard reimbursement policy, or you may contact your nearest Wabash Warranty Provider and schedule the repair with them. **If Already Remedied:**
