This notice is sent to you in accordance with the requirements of the National Traffic & Motor Vehicle Safety Act. Triple E Recreational Vehicles has decided that a defect which relates to motor vehicle safety exists in certain 2025 Unity U24CB and 2026 Unity U24CB motorhomes manufactured between August 8, 2025 and September 19, 2025

Description of Defect:

The Federal Compliance decal, OCCC decal & Tire placard decal (CD-229/OCCC/Tire) has incorrect seatbelt positions calculating incorrect OCCC weight rating. There would not be enough seatbelts if more than two passengers sat in the U-Lounge, increasing the risk of injury during a crash

To Have This Modification Performed:

The Federal Compliance decal, OCCC decals, Tire placard decal are provided in this mailing, follow the SOP enclosed to adhere the decals to the motorhome. The time needed to install the decal is about 20 minutes. If you choose to have this Recall performed by a service center other than your dealer, provide the new decals. The RV service center may require you to pay for work completed, submit the paid invoice along with receipt to recalls@tripleerv.com along with the signed return form enclosed.

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
