Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that certain model year 2025-2026 GLE vehicles fail to conform to Federal Motor Vehicle Safety Standard ("FMVSS") No. 208 (*Occupant Crash Protection*) and No. 209 (*Seat Belt Assemblies*). **Our records indicate that your vehicle is included in the affected population.**

What is the issue?



A seat belt variant without the additional child seat protection function might have been installed in the center rear seating position. The additional child seat protection function enables the center rear seat belt to lock when installing a child restraint system. If a seat belt variant without the child seat protection function is installed, the risk of injury for occupants in a child seat might be increased in the event of a crash.

What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will replace the center rear seat belt assembly on the affected vehicles. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **2 hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.

Steps to take:



- If you have not already had your vehicle repaired for this recall, find your nearest authorized Mercedes-Benz dealer at www.mbusa.com/recall to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2026010003**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.

We apologize for any inconvenience this may have caused and look forward to taking care of this important safety recall immediately.
