This notice applies to your vehicle, [VIN].

Dear Nissan Rogue Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Nissan has decided that certain 2026 Model Year Nissan Rogue vehicles fail to conform to Federal Motor Vehicle Safety Standard No. 110, "Tire Selection and Rims". Our records indicate that you own or lease the Nissan vehicle subject to this recall as identified by the VIN above and on the inside of this notice.

Reason for Recall Motivo del Retiro

Because of an issue during the manufacturing process, your vehicle may have been equipped with an incorrect spare tire. This condition may not meet the requirements of S4.3 of Federal Motor Vehicle Safety Standard (FMVSS) No. 110, "Tire Selection and Rims", which requires the spare tire to match the size and inflation pressure information shown on the tire placard. If the tire placard specifies an inflation pressure that does not match the installed spare tire, you could inflate the spare to an incorrect pressure, increasing the risk of a crash.

What Nissan Will Do Qué Hará Nissan

Your Nissan dealer will inspect both the spare tire size and tire placard. If the spare tire and tire placard match, no further action will be required. If the spare tire does not match the tire placard, the spare tire will be replaced. This service, which is conducted at no charge to you for parts and labor, could take up to half (0.5) an hour to complete. However, your Nissan dealer may require your vehicle for a longer period of time based upon their work schedule.

What You Should Do Qué Debes Hacer

Please contact your local Nissan dealer in order to arrange an appointment to have your free vehicle inspection performed as soon as possible. Please bring this notice with you when you keep your service appointment.
