Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2025 Carbon, Fuzion, Raptor Fifth Wheels. As a result, Keystone RV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

***Reason for  
this recall***

It has been decided that the vehicles in the recall population may have missing rear gate pins and or missing leg support bracket. Under certain circumstances during operation the rear gate may shift around in place, and or the patio steps may be unstable, this can lead to an increased risk of personal injury.

***What we  
will do***

Keystone representatives have been in contact with the staff at your selling dealership regarding this situation. The remedy is to install missing gate pins, and or leg support bracket. The service and parts required for this corrective action will be provided at no charge to you.

***What we  
need you to  
do***

Check for missing rear gate pins, and or patio leg support bracket. If either is missing, do not use the patio. As soon as possible, please make an appointment to have your RV serviced by your dealership. The labor time to perform this correction is approximately 1/2 hour. Please ask your dealer if you wish to know how much additional time will be needed to schedule and process your RV for this repair.

***If you have questions***

Your dealer is best equipped to obtain parts and provide service to ensure your RV is corrected as promptly as possible. Please contact Keystone Customer service if your dealer is unable to assist or if you take your RV to your dealer on the agreed service date, and the dealer does not remedy the condition within a reasonable amount of time, or without charge to you. You may be eligible to receive reimbursement if you paid to have the defect resolved prior to receiving this correspondence. Keystone Customer Service is available toll-free at 1-866-425-4369.

**BE ADVISED –**  
**Damage caused by failure to have the recall remedy completed will be the responsibility of the owner.**
