This notice applies to your vehicle, [VIN].

Dear Nissan Altima Owner:

This interim notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Nissan has decided that a defect which relates to motor vehicle safety exists in certain model year 2019 Nissan Altima vehicles. Our records indicate that you own or lease the Nissan vehicle identified by the VIN on the inside of this notice.

Reason for Recall Motivo del Retiro

Your vehicle may be equipped with an engine that contains a manufacturing defect that affects specific engine bearings and/or engine components. As a result, these components may progressively fail over time, leading to engine damage and engine failure. If the engine fails while driving, it can result in a loss of power, increasing the risk of a crash. In certain cases, a bearing failure may cause a breach in the engine block, allowing hot oil to be discharged, increasing the risk of an engine fire.

What Nissan Will Do Qué Hará Nissan

Nissan is continuing to prepare parts to remedy your vehicle. New parts for your model year 2019 Nissan Altima vehicle are anticipated to be available beginning in Q4 2025. When a sufficient quantity of final remedy parts is available, Nissan will send a letter asking you to bring your vehicle to a Nissan dealer for the repair, which will be free of charge for parts and labor.

What You Should Do Qué Debes Hacer

If you notice unusual engine noises, rough engine performance, illumination of the malfunction indicator light (MIL), or warning messages displayed in the instrument cluster, please contact your Nissan dealer to arrange an appointment for diagnosis.
