SAFETY RECALL H552: Passenger Airbag Replacement

Vehicle Affected: 2021-2024MY Jaguar E-PACE

National Highway Traffic Safety Administration (NHTSA) Recall Number: 25V-466

Dear Jaguar E-PACE Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Jaguar has decided that a defect which relates to motor vehicle safety exists in certain 2021MY - 2024MY Jaguar E-PACE vehicles.

Your vehicle is included in this Recall action.

What is the reason for this program?

During a passenger airbag deployment, the airbag may tear as a result of improper folding of the airbag during the airbag assembly process.

A torn airbag may not adequately protect an occupant in a crash, increasing the risk of injury. Additionally, a torn airbag may allow the escape of hot gases which can cause burns to occupants.

What are the warning signs of this condition?

This concern is invisible to the customer until airbag deployment.

Are there any precautions that may be taken to minimize the safety risk until the corrective measures are implemented?

Until such time as the recall has been completed, customers are advised to be extra vigilant when operating the vehicle and ensure all vehicle occupants are properly restrained with seatbelts.

What will Jaguar and your authorized Jaguar Retailer do?

Your authorized Jaguar retailer will have the passenger airbag module and associated components replaced. There will be no charge to the owners for this repair.

Please be advised that Jaguar does not yet have the parts and final repair procedure available to complete this repair. When all parts and repair processes are available you will receive a 2nd notification letter.

Owners of certain 21-23MY Jaguar E-PACE vehicles may have previously received notification their vehicle was also included in Safety Recall H491, for passenger airbag replacement. If your vehicle is included in H491 and remains unrepaired, please contact your preferred authorized Jaguar retailer and request a service date to complete the work required under "H491". If you are uncertain if your vehicle is also affected by recall H491, please enter your 17-digit VIN in the Recall search tools available at www.jaguarusa.com/ownership/vin-recall.html or www.nhtsa.gov/recall, or contact your preferred Jaguar Retailer or the Jaguar Customer Relationship Center as listed below.

What should you do?

When you receive the 2nd notification letter for recall H552, please contact your preferred authorized Jaguar retailer and provide them with your Vehicle Identification Number (VIN) and request a service date to complete the work required under Program Code 'H552'.

Attention Leasing Agencies: If you are a vehicle lessor, Federal Regulations require you to forward this notice to your lessee within ten (10) days.

How long will it take?

The work will be carried out as quickly and efficiently as possible in order to minimize any inconvenience to customers. The work is expected to take approximately (1) hour, although your retailer may need your vehicle for a longer time. Your retailer can provide you with a better estimate of the overall time for the service visit.

What if I have previously paid for this concern?

If you have already paid for this concern before the date of this letter, Jaguar is offering a refund. To qualify for a refund, during the recall repair service appointment, please provide your authorized Jaguar retailer with the original paid receipt.

To avoid delays, please do not send the receipt to Jaguar Land Rover NA, LLC.

Moved or no longer own this Jaguar vehicle?

If you are no longer the owner of this vehicle, Jaguar would appreciate the name and address of the new owner (if known); please fill out and return the enclosed return postage-paid card.

What should you do if you have further questions?
