### NHTSA Recall No. 25V903

#### This notice applies to your vehicle, VIN

Dear Lamborghini Owner or Lessee,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Automobili Lamborghini S.p.A. has decided that certain Model Year 2019 to 2024 Urus vehicles fail to conform to Federal Motor Vehicle Safety Standard No. 111, "Rear Visibility." 49 CFR 577.5(c)(2). Our records indicate that you are the owner of a vehicle in this recall.

#### What is the issue?

In the affected vehicles, a combination of electrical noise, diminished shielding integrity, timing and insufficient software robustness may adversely affect the Top View System operation, which may prevent the rearview camera image from displaying. A rear-view camera image that does not display decreases the driver's visibility, increasing the risk of a crash.

For the reason set forth above, it is therefore necessary to update these vehicles. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

#### What will Lamborghini do?

Lamborghini is carrying out a recall of these vehicles. The remedy is currently under development and will be advised in due course. There will be no charge to the owners for this repair. The work will be carried out as quickly and efficiently as possible in order to minimize any inconvenience to customers. When the remedy is available, your retailer will be able to provide you a better estimate of the overall time for the service visit. We apologize for any inconvenience this recall may cause.

#### What Do You Need to Do?

**When the remedy is available, you will receive the second notification letter. At that time, we encourage you to contact your authorized Lamborghini dealer to schedule an appointment to have this important free update performed.** Please bring this letter and your Service Booklet with you when you visit the dealer, so that we can make all necessary entries. Until the time the recall has been completed, customers are advised to be extra vigilant when operating the vehicle.
