Subject: Incorrect Number of Belted Seats on Label/FMVSS 120

This letter serves to acknowledge Forest River, Inc.'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

Forest River, Inc. (Forest River) is recalling certain 2025-2026 Entourage motorhomes. The Cargo Carrying Capacity (CCC) label may incorrectly state 7 seat belted positions, when the motorhome has 8 positions, which can allow the motorhome to be overloaded. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 120, "Wheels and Rims-Other than Passenger Cars."

Consequence:

An overloaded vehicle increases the risk of a crash.

Remedy:

Dealers will remove one of the seat belts, free of charge. Owner notification letters are expected to be mailed April 26, 2026. Owners may contact Forest River customer service at 1-574-825-8602. Forest



River's number for this recall is 210-2041.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Under 49 U.S.C. § 30112(a), it is illegal for anyone, including a manufacturer, distributor, dealer, or retailer to sell an item of equipment or vehicle that fails to comply with all applicable Federal motor vehicle safety standards.

As stated in 49 U.S.C. § 30118(f), submission of eight consecutive quarterly reports followed by three annual reports is required. As described in 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter. The first of three consecutive annual status reports will be due on, or before, 1 year after the eighth quarterly report was submitted.
