Subject: Missing Welds on Personnel Jib Platform

This letter serves to acknowledge Altec Industries, Inc.'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

Altec Industries (Altec) is recalling certain 2024-2026 AC Series Crane vehicles. The inside joints between the side plates and the base plates of the 26-foot insulating personnel jib (IJ26) may be missing welds.

Consequence:

Missing welds can lead to platform joint failure due to fatigue or overload, resulting in the platform falling from the boom tip, increasing the risk of injury.

Remedy:

Altec will advise owners to inspect the IJ26 jib for missing welds. If the welds are missing, the jib should be taken out of service immediately. Altec will add the missing welds or provide a repair procedure and

kit, free of charge. Owner notification letters are expected to be mailed August 7, 2026. Owners may contact Altec customer service at 1-877-462-5832. Altec's number for this recall is MAB-3330.

Please be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in 49 U.S.C. § 30118(f), submission of eight consecutive quarterly reports followed by three annual reports is required. As described in 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter. The first of three consecutive annual status reports will be due on, or before, 1 year after the eighth quarterly report was submitted.
