Inadequate clamp load at the axle to spring interface resulting from inadequate initial preload combined with preload losses caused by joint relaxation and impact loading.

If the ubolt loosens, the axle may shift, which can reduce vehicle stability and increase the risk of a crash.

**Description of the cause:**

An investigation is ongoing, the cause of the loose ubolts has not been definitively established.

Customers can visually inspect the suspension before travel, loose or shifting components should be fixed before travel.

## Chronology

January 25, 2025 – Grand Design RV (GDRV) receives notification of a post-remedy failure associated with recall population axle (recall 23v490). This incident involved spring slip occurring after completion of the recall remedy.

January 25, 2025 – April 16, 2025 – During routine claim reviews, GDRV is notified of three additional post-recall incidents.

April 15, 2025 – GDRV meets with Lippert Components, Inc. (LCI) to inform them of the known post-recall spring slip incidents. After reviewing the available information, LCI states that they will continue monitoring the situation.

May 10, 2025 – GDRV receives VOQ 11660135 reporting a post-recall spring slip condition (recall 24v193). GDRV opens an internal investigation in partnership with LCI. As part of this investigation, prior claims are reviewed and additional post-recall incidents are identified that had not previously been identified.

August 5, 2025 – GDRV and LCI begin holding weekly investigation meetings to coordinate data collection, field analysis, and test planning.

September 10, 2025 – GDRV and LCI jointly meet with NHTSA to discuss post-recall spring slip allegations. During this period, LCI initiates an expanded testing program, including torque-retention studies, component-level evaluations, and test-track durability testing.

November 7, 2025 – GDRV and LCI again meet with NHTSA to provide updates on ongoing testing and preliminary findings.

January 5, 2026 – LCI presents updated test data to GDRV. The results indicate that the remedy implemented under recalls 23v490 and 24v193 is not sufficient to prevent spring slip across the affected axle population.

January 8, 2026 – GDRV and LCI meet with NHTSA to provide a technical update based on testing conducted to date.

January 15, 2026 – GDRV executive leadership meets to review all gathered data, test results, and field information. The leadership team unanimously votes to sunset recalls 23v490 and 24v193 and to initiate a new recall covering the entire previously addressed population, utilizing an improved and more robust remedy.

The remedy program is not yet available. LCI is evaluating design and manufacturing changes and performing testing to determine an appropriate and effective remedy. GDRV will submit a supplemental Part 573 once the remedy is finalized and will notify owners and dealers at that time.

**How remedy component differs from recalled component:**

The remedy components are still under development. LCI is conducting engineering analysis and durability testing to identify necessary modifications to prevent spring slip. Design and specification

differences between the remedy and recalled components will be reported in a supplemental filing once development is complete.

**Identify how/when recall condition was corrected in production:**

Grand Design stopped using 7000 and 8000 lb Curt axles in production on 11/2/2024.
