Chronology

October of 2026 received a complaint of exhaust fumes in bedroom. 2 other verbal complaints were made after that of smelling exhaust fumes in the bedroom. On 10/16/2025 an engineering ticket was submitted to the engineering department to investigate the issue. March of 2026 engineering communicated the testing results showed that there was an unacceptable amount of carbon monoxide entering the bedroom through the slide out under the right conditions. March 5th the decision was made that this needed to be recall for this issue.

Description of Remedy

Remedy Type: Inspect, Repair

Consumer Advisories: Do Not Drive Park Outside

Description of remedy program:

ATC will remedy the defect without charge to the customers. The generator exhaust will be rerouted reward of the bedroom slide out and an additional carbon monoxide detector will be installed in the bedroom. ATC will provide parts and prints to an approved service center or dealer. Estimated time for fix is 2.5 hours.

How remedy component differs from recalled component:

The remedied component will have the generator exhaust exiting reward of the bedroom slide out and a carbon monoxide detector install in the bedroom

Identify how/when recall condition was corrected in production:

Effective 3/11/2026 production began routing the generator exhaust to exit reward of the bedroom slide out and installing a carbon monoxide detector in the bedroom on all units that have a bedroom slide out and a generator
