Am email was received from an (NHTSA) to the GPM Pres. Mon, Jan 12, 2026. The email containing a page from a NHTSA inspection report, "APPENDIX C LABORATORY NOTICE OF TEST FAILURE TO OVSC"

It referenced a GPM 2022 Green Power Beast School Bus - VIN 1G9SP5GH3NP492055 and a report # TR-P45235-01-NC created by Test Lab: Applus IDIADA, Test Date: 12/18/25.

The document provided, noted a test failure description that the inspected unit failed to meet the requirements according to §571.111, S9: Requirements for School Buses. - S9.3 (C): Each school bus which has a mirror installed in compliance with S9.3(a) that has an average radius of curvature of less than 889 mm, as determined under S12, shall have a label visible to the seated driver. The label shall be printed in a type face and color that are clear and conspicuous. The label shall state the following:

"USE CROSS VIEW MIRRORS TO VIEW PEDESTRIANS WHILE BUS IS STOPPED. DO NOT USE THESE MIRRORS TO VIEW TRAFFIC WHILE BUS IS MOVING. IMAGES IN SUCH MIRRORS DO NOT ACCURATELY SHOW ANOTHER VEHICLE'S LOCATION.

The inspectors did not find the label installed.

Representatives reviewed records of BEAST builds from beginning of production to 02/24/2026, and were not able to validate that the required label, GPM - P/N 700-000434 (Garmin P/N - GP207)

During a conference call between NHTSA & GPM 02/26/2026 to discuss subjects including report TR-P45235-01-NC, GPM advised that they believed the GPM model - NANO-BEAST would also be involved.

GPM agreed to determine the populations affected, that a 573 Non-Compliance campaign would be prepared, In addition, a dealer/customer notice was also drafted.
