Defect / Noncompliance Description

Description of the defect or noncompliance:

Denago EV has determined that certain previously sold low-speed vehicles may fail to conform to Federal Motor Vehicle Safety Standard ("FMVSS") No. 141, "Minimum Sound Requirements for Hybrid and Electric Vehicles." The affected vehicles were delivered for sale without an installed Acoustic Vehicle Alerting System. As a result, the affected vehicles may not emit the exterior pedestrian alert sound required during the applicable low-speed operating conditions specified in FMVSS No. 141.

FMVSS1: 141 - Minimum Sound Requirements for Hybrid and Electric Vehicles

FMVSS2:

Description of the safety risk, including crash, fire, death, injury:

This condition may increase the risk of a crash or injury to pedestrians, cyclists, or other road users. Because the affected vehicles may not emit the required pedestrian alert sound, pedestrians, cyclists, and other road users may have a reduced ability to detect the presence or movement of an affected vehicle during low-speed operation. As of June 10, 2026, Denago EV is not aware of any crashes, fires, deaths, or injuries related to this condition.

Description of the cause:

Due to a deviation in the development process, certain vehicles might not meet the specifications regarding minimum volume level of the pedestrian alert sound.

Identification of any warning that can occur:

The driver will not receive a warning.

Chronology

On May 8, 2026, Denago EV received an information request from the National Highway Traffic Safety Administration's Office of Vehicle Safety Compliance. The information request included a question regarding compliance with FMVSS No. 141.

On May 15, 2026, Denago EV initiated a review of the FMVSS No. 141 requirements and began collecting production, assembly, and vehicle configuration records for the potentially affected vehicle population.

On June 1, 2026, as a result of that review, Denago EV became aware that certain previously sold low-speed vehicles may have been delivered for sale without an installed acoustic vehicle alerting system.

Denago EV thereafter conducted a further review of the affected vehicle population and evaluated the vehicles' compliance with FMVSS No. 141. Based on that review, Denago EV determined that the affected vehicles may not comply with the requirements of FMVSS No. 141.

On June 3, 2026, following approval by executive management, Denago EV determined that a noncompliance existed and decided to conduct a voluntary recall to provide and install the acoustic vehicle alerting system on the affected vehicles.

Denago EV will provide an acoustic vehicle alerting system remedy kit, consisting of the exterior sound generator/speaker and associated installation components, for all affected vehicles. The remedy kits will be distributed through authorized Denago EV dealers. Affected owners will be provided with installation instructions and may obtain assistance from their authorized Denago EV dealer regarding installation of the remedy kit. The installation procedure is straightforward and is expected to require a minimal amount of time to complete. Upon installation of the remedy kit, the vehicle will comply with the sound requirements of FMVSS No. 141
