Certain MY22-27 Blue Bird Vision vehicles may be equipped with an exhaust hanger cotter pin that could rub against the hydraulic brake line.

Description of the safety risk, including crash, fire, death, injury:

A leaking hydraulic brake line could result in brake fluid exposure to the exhaust and/or a brake system failure, further increasing the risk of a thermal event and/or crash.

Description of the cause:

Rubbing between the exhaust hanger cotter pin and hydraulic brake line could result in brake fluid leaking.

Identification of any warning that can occur:

The driver may be made aware of the issue through a potential loss of pressure in braking.

Chronology

- March 27, 2026: NHTSA reached out to Blue Bird about a customer VOQ filing. The VOQ stated that, during inspection the customer observed an exhaust hanger cotter pin making direct contact with a hydraulic brake line.
- April, 2026: Blue Bird began an in-depth review of the exhaust hanger and brake line installations.
- July, 2026: Blue Bird's investigation revealed the supplier part did not match the released CAD. A review of build variation in production revealed the potential of a contact.
- July, 2026: Blue Bird revised the design in production to a split pin to eliminate any potential contact.
- July 20, 2026: Blue Bird submitted a defect report.

Blue Bird is aware of 6 warranty cases submitted between August 2024 and December 2025.

A Blue Bird dealership or owner will replace the exhaust hanger cotter pin. If contact to the brake line is found, the brake line will be replaced.

How remedy component differs from recalled component:

Vehicles outside of the population have an exhaust hanger cotter pin that does not interfere with the hydraulic brake line.

Identify how/when recall condition was corrected in production:

In July 2026, the cotter pin was replaced by a split pin in production, while a new clip design is being completed.
