Description of the defect or noncompliance:

Certain Volvo VNL(4) and VNR(4) may be equipped with roof marker lights that may not have appropriate connector housing lengths.

FMVSS1: 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS2:

Description of the safety risk, including crash, fire, death, injury:

This can result in the center marker lamp connection failing and the light not illuminating which may reduce visibility and increase the risk of a crash. As such, these trucks may fail to comply with the requirements of Federal Motor Vehicle Safety Standard number 108, "Lamps, Reflective Devices, and Associated Equipment."

Description of the cause:

Tolerance stack between pins and connector are line to line which results in faulty connection when any parts are not at nominal tolerance value.

Vehicles will be recalled, and the center roof marker lamp will be replaced.

How remedy component differs from recalled component:

New marker lamps will have updated connector length to ensure proper tolerance per design guidelines.

Identify how/when recall condition was corrected in production:

Stock was sorted at the supplier and a containment inspection put in place for all shipments starting 06-05-2026.

Stock was sorted at our factory, and all NOK components were scrapped on 06-05-2026.

Vehicles still on site have been put on a stop shipment and will not be released until corrected with verified clean components.
