Defect / Noncompliance Description

Description of the defect or noncompliance:

Certain MY21-27 Blue Bird Vision vehicles may be equipped with an unfused 12V power wire on the C or D-Zone harness that could be damaged from abrasion, further resulting in a potential disruption of critical safety functions on fused circuits.

Description of the safety risk, including crash, fire, death, injury:

A short to ground could result in the unfused wire radiating heat to the surrounding wires in the harness, possibly disrupting critical safety functions. The affected safety functions include: front warning lights, marker lights, rear brake lights, reverse lights, license plate lights, and rear warning lights. The signal of the mentioned functions could be disrupted, increasing the risk of a crash.

Description of the cause:

Rubbing between the unfused 12V power wire and edges of body components could result in the C or D-Zone harness overheating, ultimately resulting in a short to ground.

Identification of any warning that can occur:

The driver may be made aware of the issue through an abnormal noise from the short, followed by the smell of melting plastic and/or visible melting of the wire molding and/or wire cover. Should such warnings occur, the driver should pull over and power off the vehicle.

Chronology

- April 2026: Blue Bird received field complaints where bus units experienced thermal stress of the C-Zone body harness.
- May 2026: Blue Bird began an in-depth review of the installation of the 12V power wire on the C and D-Zones. Blue Bird's investigation revealed that the power wire was rubbing on bus component edges over time, resulting in abrasion.
- July 2026: Blue Bird further ruled out the risk of a thermal event, as the C and D-Zone harnesses are contained within and around non-combustible materials. In the event of a short, all sparks would be contained.
- August 5, 2026: Blue Bird's Safety Committee determined that this issue affects safety critical components, deeming it a safety recall.
- August 10, 2026: Blue Bird submitted a defect report.

Blue Bird is aware of 7 warranty claims submitted between May 2023 and June 2026. Blue Bird is not aware of any injury or death related to this issue.

Description of remedy program:

A Blue Bird dealership or owner will retrofit the C and D-Zone wire harnesses with an in-line fuse. They will further inspect specified areas for a potential rubbing condition and mitigate, if necessary. If the fuse blows after the retrofit takes place, the harness will be traced for a short to ground and further repaired or replaced.

How remedy component differs from recalled component:

Vehicles outside of the population have body electrical components that are mounted in the outside side electrical panel. In the event of a direct short, a fuse in the side electrical panel would trip and disconnect the power source.

Identify how/when recall condition was corrected in production:

The wiring harness supplier will add an in-line fuse. Specified areas are being further inspected for a rubbing condition in production and mitigated, if necessary.
