Chronology

7/8/26: Jayco Motorized group informed Compliance via email of a situation where the label was incorrect. Compliance reached out to the Jayco chassis group to determine scope.

7/13/26: The incident was reviewed by the Warranty Incident Review Committee (WIRC). The members of WIRC decided to elevate it to the Corrective and Preventive Action Committee (CPAC) due to a potential safety issue.

7/15/26: The Corrective and Preventive Action Committee (CPAC) met to discuss this incident and decided more information needed to be collected.

8/5/26: The Corrective and Preventive Action Committee (CPAC) met to discuss this incident and elevated it to the Safety Steering Committee due to understanding the scope and the issue.

8/27/26: The Safety Steering Committee (SSC) voted in favor of proceeding with a noncompliance recall for failing to comply with requirement of the 49 CFR Part 120 section 5.3 "Wheels and rims-other than passenger cars"
