Recall population is the entire population of units built with the optional tire package known as "Lineage 43."

Defect / Noncompliance Description

Description of the defect or noncompliance:

The affected vehicles are equipped with tires whose marked speed rating is below the vehicle's attainable (governed) top speed. As a result, the vehicle is capable of operating at speeds that exceed the speed capability marked on the installed tires.

Description of the safety risk, including crash, fire, death, injury:

If vehicle speed exceeds the maximum tire rated speed, the tire structure could be compromised, increasing the risk of tire failure and of a crash.

26V595**Description of the cause:**

The installed tires carry a speed rating below the vehicle's governed top speed. Grand Design is working with the tire manufacturer to confirm the tires' suitability for the application. Pending that confirmation, Grand Design has elected to recall as a precautionary measure.

Chronology

- 9/2/2026 A customer notified Grand Design that the installed tires carried a K speed rating, which is below the vehicle's governed top speed.
- 9/2/2026 Grand Design inspected its inventory and determined that the tires on hand were K speed rated.
- 9/2/2026 Grand Design contacted its tire distributor, who evaluated their stock and confirmed it was also K speed rated, indicating the tires received would have been K rated.
- 9/4/2026 Grand Design's Product Safety Committee met and voted to address the concern of the tire speed rating being below the vehicle's attainable (governed) top speed.
- 9/4/2026 Grand Design contacted the retail owners as a precautionary measure, asking them to maintain a recommended speed until the condition is fully evaluated.
