Dear Winnebago Owner:

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Our records indicate that you have purchased a vehicle with the serial number which appears above.

### **REASON FOR THIS RECALL**

Winnebago Towable (Winnebago) is recalling certain 2026 Access travel trailers. The Gross Axle Weight Rating (GAWR) may not be listed on the certification label. As such, these vehicles fail to comply with the requirements of 49 CFR Part 567, "Certification."

Missing weight information may lead to unintentionally overloading the vehicle, increasing the risk of a crash.

### **WHAT WE WILL DO**

On affected vehicles, Winnebago of Indiana will replace the Vehicle Certification Label and the Tire and Loading Information label with a new corrected label and installation instructions. The customers will also have the option to utilize a dealer for installation. The time necessary to complete the repair will be approximately 20 minutes. Please allow additional time for the dealer to process your vehicle. **This repair will be done at no charge to you.**

### **WHAT YOU SHOULD DO**

Step 2: Clean area and wipe dry. Apply new VIN Tag to the compartment door.
