Dear Hino Truck Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Hino has decided that a defect, which relates to motor vehicle safety, exists in certain 2026MY NE7D, NH7G, NH7K, NJ7D, NJ7E, NV7D and NV7G, conventional trucks. You received this notice because our records, which are based primarily on state registration and title data, indicate that you are the current owner.

What is the Condition?

The subject vehicles may have been distributed with an incorrect owner's manual, which includes maintenance instructions that are inaccurate as applied to the subject model. The inaccurate instructions include torque tightening specifications for the front U-bolt in periodic maintenance that could be excessive. If the front U-bolt is re-tightened following instructions from the incorrect owner's manual, in the worst-case scenario, a U-bolt could be broken and come off. The alignment of the front axle and leaf springs may shift, potentially causing a loss of vehicle control that could result in increased risk of a crash.

Customers who have received the "Customer Notification Letter for Recall (M0490)", who may have paid for repairs due to this defect may apply for reimbursement for those repair costs. All pre-notification reimbursement requests for repairs which were performed until a date 10 days after the final customer notification was made will be considered by Hino for reimbursement. Hino will also reimburse all Parts, Labor, and miscellaneous costs directly related to the remedy of this defect. Requests for reimbursement, including paid receipts, should be directed to warranty@hino.com.

What will Hino do?

Your authorized Hino Dealer will provide the correct owner's manual that has the manufacture campaign number (M0490) indicated on the cover page. Please make an appointment with your authorized Hino Dealer to have the remedial work performed. This repair will be performed at **NO COST** to you.

What should you do?

This is an Important Safety Recall

Please contact any authorized Hino dealer to schedule an appointment to have the remedial work performed as soon as possible. This repair will take approximately 0.5 hour to complete.

You do not need an owner letter to have this recall completed; however, to assist the dealer in confirming vehicle eligibility, we request that you present this notice at the time of your service appointment.

If you would like to update your vehicle ownership or contact information, you may do so by contacting Hino Warranty at warranty@hino.com or by telephone 1-248-699-9390. You will need your full 17-digit Vehicle Identification Number (VIN) to update the new ownership or contact information.

If you are a vehicle lessor, Federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.
