This notice applies to your vehicle, [VIN].

Dear Nissan Cube Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Nissan has decided that a defect which relates to motor vehicle safety exists in certain 2009 Model Year Nissan Cube vehicles. Our records indicate that you own or lease the Nissan vehicle subject to this recall as identified by the VIN above and on the inside of this notice.

Reason for Recall Motivo del Retiro

The driver's airbag inflator in your vehicle may have been manufactured with an improper weld between the inflator and its base. As a result of the insufficient weld, your airbag module could detach from the steering wheel during airbag deployment. If this condition occurs, there is an increased risk of injury to the occupant in the event of a crash where driver's airbag deployment is warranted.

What Nissan Will Do Qué Hará Nissan

Your Nissan dealer will inspect your driver's airbag inflator serial number. If the serial number is confirmed to be within the suspect inflator population, your dealer will replace the driver's airbag module with a new module from a different supplier. This service, which is conducted at no charge to you for parts and labor, could take up to one (1.0) hour to complete. However, your Nissan dealer may require your vehicle for a longer period of time based upon their work schedule.

What You Should Do Qué Debes Hacer

Please contact your local Nissan dealer to arrange an appointment to have your free vehicle repair scheduled as soon as possible. Please bring this notice with you when you keep your service appointment.
