IMPORTANT SAFETY RECALL

Rearview Camera

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA US LLC has decided that certain [2019 and 2023 Model Year (RU) Chrysler Pacifica, 2024 Model Year (DT) Ram 1500 and 2024 and 2025 Model Year (JL) Jeep® Wrangler] vehicles fail to comply with Federal Motor Vehicle Safety Standard (FMVSS) No. 571.111 - Rear visibility.

RECALL DESCRIPTION

Some of the above vehicles may have been built with debris from a Central Vision Processing Module (CVPM) machining process which may prevent the rearview camera image from displaying. **Failure to display a rearview image can increase the risk of a crash.**

The condition above fails to comply with the requirements of FMVSS No.571.111 S6.2.6 which requires that "The rear visibility system default to the rearview image...at the beginning of each backing event, regardless of any modifications to the field of view that the driver had previously selected."

YOUR VEHICLE HAS ALREADY BEEN REMEDIED

According to our service records, the CVPM in your vehicle ^[1] was previously replaced, and no further action is needed.

This notification is provided for your records only. There is nothing more that you need to do.

WHAT IF I HAVE QUESTIONS REGARDING THIS RECALL?

If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.
