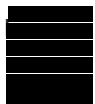

IMPORTANT SAFETY RECALL SECOND NOTICE – ACTION REQUIRED

This notice applies to your vehicle, VIN 1HD1ZC426 [REDACTED]

Dear Harley-Davidson® Motorcycle Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Harley-Davidson Motor Company, Inc. has decided that a defect which relates to motor vehicle safety exists in certain model year 2021 – 2026 Sportster S (RH1250S) motorcycles. We are notifying you because our records indicate that you may own one of these motorcycles. **We previously notified you of this recall; however, our records show that the recall remedy has not yet been completed on your motorcycle. We urge you to contact your authorized dealer as soon as possible to schedule a free inspection/repair.**

What is the Issue?

- The upper triple clamp may fracture under extreme loading conditions. An upper triple clamp that fractures while the motorcycle is being operated could lead to a loss of control, increasing the risk of a crash. ***Note: This Recall does not replace Recall 0190 and all applicable motorcycles must have the upper triple clamp replaced prior to executing Recall 0191. Due to a supplier error, there may be a concern with the part as-built on your motorcycle or the part installed during the Recall 0190 repair.***

What Should You Do?

- **This Recall does not replace Recall 0190. Therefore:**
 - **If your motorcycle was included in Recall 0190 and you have not had the repair performed,** you must contact your authorized Harley-Davidson motorcycle dealer and arrange an appointment to have the Recall 0190 and Recall 0191 repairs applied to your motorcycle.

- **If your motorcycle was included in Recall 0190 and you *did* previously have the Recall 0190 repair performed**, you must return to your authorized Harley-Davidson motorcycle dealer to have your upper triple clamp inspected to ensure the correct replacement part was installed. If an incorrect part was installed, your dealer will replace it with the correct part.
- **If your motorcycle was not included in the population covered by Recall 0190, but is covered by Recall 0191**, please contact your authorized Harley-Davidson motorcycle dealer to arrange an appointment to have the upper triple clamp on your motorcycle inspected and, if necessary, replaced.

If you are unsure about the recall or remedy status of your motorcycle, you may contact Harley-Davidson for assistance at 1-800-258-2464 in the U.S. or 1-414-343-4056 world-wide.

If needed, recall kits are available for order by authorized Harley-Davidson dealers. Any associated repairs will be performed at no cost to you and should take approximately 60 minutes. However, due to scheduling and recall kit availability, the dealer may require your motorcycle for a longer period. Once the remedy has been completed, your dealer will ask you to sign a recall claim.

If you have sold your motorcycle and have an address for the current owner, it is important that you forward this notice to the new owner. Alternatively, you may contact us at the Harley-Davidson phone numbers listed below and provide us with the new contact information so that we may notify the new owner of this recall. Also, federal law requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten (10) days.

What If You Have Additional Questions or Concerns?

If you previously paid to remedy the specific condition that is the subject of this recall, you may be eligible for reimbursement. For more information regarding eligibility, or if you take your motorcycle to your dealer on a mutually agreed upon date and they are unable to perform the required service to your satisfaction, please contact Harley-Davidson Motor Company, Inc. for immediate assistance at 1-800-258-2464 in the U.S. or 1-414-343-4056 world-wide.
