IMPORTANT SAFETY RECALL

Rearview Camera

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA US LLC has decided that certain [2019 and 2023 Model Year (RU) Chrysler Pacifica, 2024 Model Year (DT) Ram 1500 and 2024 and 2025 Model Year (JL) Jeep® Wrangler] vehicles fail to comply with Federal Motor Vehicle Safety Standard (FMVSS) No. 571.111 - Rear visibility.

WHY DOES MY VEHICLE NEED REPAIRS?

The Central Vision Processing Module (CVPM) may be improperly programmed, which can prevent the rearview camera image from displaying. **Failure to display a rearview image can increase the risk of a crash.**

The condition above fails to comply with the requirements of FMVSS No.571.111 S6.2.6 which requires that "The rear visibility system default to the rearview image...at the beginning of each backing event, regardless of any modifications to the field of view that the driver had previously selected."

HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

The remedy for this condition is not currently available. We are making every effort to finalize the remedy, and will service your vehicle free of charge (parts and labor) when the remedy is available.

FCA US LLC will contact you again, by mail, with a follow-up recall notice when the remedy is available. Once you receive your follow-up notice, simply contact your Chrysler, Jeep®, Dodge or RAM dealer right away to schedule a service appointment ^[1] ^[2]. Additional options for your next steps are included on the left side of this notification. We appreciate your patience.

WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have already experienced this specific condition and have paid to have it repaired, you may visit www.fcarecallreimbursement.com to submit your reimbursement request online ^[3]. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days. If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.
