Door Airbag Pressure Sensor

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA US LLC has decided that certain [2022 through 2026 (WL) Jeep® Grand Cherokee] vehicles fail to comply with Federal Motor Vehicle Safety Standard (FMVSS) No. 214 Side Impact Protection.

WHY DOES MY VEHICLE NEED REPAIRS?

The Occupant Restraint Controller (ORC) module on your vehicle ^[1] may have been built with software which can cause delayed deployment of the side airbag (SAB). **A delayed deployment of the SAB may reduce front seat occupant protection in certain types of crashes, increasing the risk of injury to motor vehicle occupants.**

The condition described above does not comply with Federal Motor Vehicle Safety Standard (FMVSS) No. 571.214 Side Impact Protection which requires Side Air Bag (SAB) deployment to satisfy injury criteria with multiple occupant sizes in various crash modes.

HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

The remedy for this condition is not currently available. We are making every effort to finalize the remedy, and will service your vehicle free of charge (parts and labor) when the remedy is available.

FCA US LLC will contact you again, by mail, with a follow-up recall notice when the remedy is available. Once you receive your follow-up notice, simply contact your Chrysler, Jeep®, Dodge or RAM dealer right away to schedule a service appointment ^[2]. Additional options for your next steps are included on the left side of this notification. We appreciate your patience.

WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have already experienced this specific condition and have paid to have it repaired, you may visit www.fcarecallreimbursement.com to submit your reimbursement request online ^[3]. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days. If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.
