Dear INFINITI QX80 Owner:

This interim notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. INFINITI has decided that certain 2025 Model Year INFINITI QX80 vehicles equipped with optional 22-inch wheels fail to conform to CFR 49 Part 567; "Certification" and with Federal Motor Vehicle Safety Standard No. 110; "Tire Selection and Rims." Our records indicate that you own or lease the INFINITI vehicle subject to this recall as identified by the VIN on the inside of this notice.

### Reason for Recall

#### Motivo del Retiro

The Certification Label located on the driver's side door pillar near the door latch of your vehicle may contain incorrect Gross Axle Weight Rating (GAWR) information required by the applicable regulations. Having the correct GAWR information on the Certification label is important because overloading your vehicle may increase the risk of a crash.

### What INFINITI Will Do

#### Qué Hará INFINITI

INFINITI is currently preparing labels to remedy your vehicle. Beginning this Fall 2026, INFINITI will mail your new overlay label that contains the corrected GAWR value for your vehicle and include instructions on how to affix it to your existing Certification Label.
