Some customers have reported air conditioning performance issues under certain driving conditions. This was due to a potentially faulty underhood air conditioning discharge hose, and affects a limited number of 2009 model year Volkswagen Routan vehicles equipped with a 3.8 L engine. Our records show that your vehicle was built within the production date range of vehicles that may experience this issue.

## What is the problem?

The affected vehicles have an air conditioning discharge hose that may develop a crack and leak refrigerant. If this happens, the air conditioning system may not properly cool down the vehicle.

## What will Volkswagen do?

At no cost to you, we will inspect and, if necessary, replace the air conditioning discharge hose in your vehicle. Both the inspection and repair (if needed) will take about one hour and will be free of charge. Your dealer can also address any other concerns you may have with your vehicle at this service visit.
This no-cost repair action will only be available until October 31, 2013, and we encourage you to contact your authorized Volkswagen dealer and arrange for an appointment at your earliest convenience. Please keep in mind that your dealer may need additional time for the preparation of the update, as well as to accommodate their daily workshop schedule. Dealers will not be able to perform this update free of charge after October 31, 2013.
