What is the condition?

This condition may occur if the subject vehicle is operated in cold climate regions of the United States where road salts are frequently used. Water can splash backwards with high concentrations of road salt, reach the spare tire carrier and corrode the spare tire carrier assembly cable.

This Special Service Campaign offers to apply a Corrosion Resistant Compound (CRC) to the end of the spare tire carrier cable on 1998 - 2010 model year Sienna 2WD vehicles (equipped with a spare tire carrier) if the owner believes his/her vehicle will be operated in areas where a high concentration of road salt is frequently applied.

What is included in this Special Service Campaign?

If you believe your vehicle will be operated in cold climate regions of the United States where high road salt is frequently used, any authorized Toyota Dealer will apply a Corrosion Resistant Compound (CRC) to the end of your vehicle's spare tire carrier cable at NO CHARGE to you.

Vehicles originally sold-in and currently registered in the following states as well as American Samoa, Guam, Puerto Rico and Saipan will receive this offer:

How do you take advantage of this Special Service Campaign?

If you believe your vehicle will be operated in cold climate regions of the United States where a high concentration of road salt is frequently applied, please contact an authorized Toyota Dealer and schedule an appointment to have a Corrosion Resistant Compound (CRC) applied to the end of your vehicle's spare tire carrier cable. The application of the CRC will take approximately thirty minutes. However, depending upon the dealer's work schedule, it may be necessary to make your vehicle available for a longer period of time.

If your vehicle is covered by this Special Service Campaign you do not need an owner letter to request that this campaign be conducted; however to assist the dealer in confirming vehicle eligibility, we request that you present this notice at the time of your service request.

This SSC will be launched in phases consistent with the age of the vehicle. Phase 2 will cover 2007 - 2009 model year Sienna vehicles. Subsequent phases will include the remaining Sienna vehicles covered by this SSC (2010 model year):

Phase 1: Certain 1998 through 2006 Model Year Sienna 2WD vehicles

Phase 2: Certain 2007 through 2009 Model Year Sienna 2WD vehicles

Phase 3: Certain 2010 Model Year Sienna 2WD vehicles

Q1: What is the condition?

This condition may occur if the subject vehicle is operated in cold climate regions of the United States where A1: road salts are frequently used. Water can splash backwards with high concentrations of road salt, reach the spare tire carrier and corrode the spare tire carrier assembly cable.

Q2: Are there any warnings this condition exists?

No, there are no specific warnings that this condition exists.

Q3: What is the cause of this condition?

The corrosion resistance of the spare tire carrier cable is insufficient when vehicles are operated in areas A3: where a large amount of road salt is applied.

What is Toyota going to do? Q4:

This SSC offers to apply* a Corrosion Resistant Compound (CRC) to the end of the spare tire carrier cable A4: on certain 1998 - 2010 model year Sienna 2WD vehicles (equipped with a spare tire carrier) at no charge. Vehicles originally sold-in and currently registered in the following states and American Samoa, Guam, Puerto Rico and Saipan will receive this offer:

AK, AL, AR, AZ, CA, CO, FL, GA, HI, IA, ID, KS, LA, MO, MS, MT, NC, ND, NE, NM, NV, OK, OR, SC, SD, TN, TX, UT, WA, or WY

*Based upon the inspection results, Toyota may need to repair the spare tire carrier cable prior to applying the CRC.

When will phase 2 owners be notified?

Toyota will notify owners of covered vehicles by first class mail beginning in mid-December 2010

Q5: What should customers do?

A5: Owners of Sienna vehicles covered by this phase, who believe their vehicle will be operated in areas where high road salt is frequently used, should bring their vehicle to a Toyota dealer to have the Corrosion Resistant Compound (CRC) applied to the end of their vehicle's spare tire carrier cable.

Q6: Which and how many vehicles are involved in the Special Service Campaign?

A6: There are approximately 733,500 vehicles covered.

Are there any other Toyota or Lexus vehicles involved?

A7: No other Toyota or Lexus vehicles are involved.

- Q8: What is the production period of the Sienna vehicles covered by this Special Service Campaign?
- A8: The vehicles covered by the SSCSe100377706r4677991 from August 1997 to January 2010.
- Q9: How long will the remedy take?
- A9: The CRC application and/or spare tire carrier cable repair will take approximately one hour. However, it may take longer based upon the inspection results and the dealer's work schedule.
- Q10: What if a customer has previously paid to replace the vehicle's spare tire carrier for this specific condition?
- A10: Reimbursement consideration instructions will be provided in the owner letter for those customers that have previously paid to replace the spare tire carrier cable for this specific condition.
- Q11: What should an owner do if they experience the condition, or have immediate concerns about their vehicle?
- A11: If an owner has any immediate concerns they are requested to contact their local Toyota dealer for diagnosis, and if applicable, necessary repair.
