This Service Bulletin provides information regarding ECM reprogramming file availability to address P1235, “High-Pressure Fuel Pump Abnormal”.

**IMPORTANT:** Be sure to confirm the latest SSMIII software version number, **1.35.49.27 dated Nov. 2012** (or newer) has been installed before attempting to perform this procedure.

### COUNTERMEASURE IN PRODUCTION

A change to the ECM logic was incorporated into production on September 12, 2012 starting with the following VINs:
