NOTE:

- Perform this UPDATE on all applicable vehicles within FEDEREAL EMISSIONS WARRANTY.
- It is MANDATORY to perform UPDATES on all applicable vehicles in dealer inventory PRIOR TO RETAIL SALE.
- Inform customers that this UPDATE will be available free of charge as long as their vehicle is within the Warranty parameters outlined in this UPDATE.

- If this UPDATE appears to have already been performed but the code still shows open in ElsaWeb, contact Warranty before proceeding further. Another dealer may have recently performed this UPDATE but not yet entered a claim for it in the system.
- ElsaWeb may also show additional open action(s); if so, inform your customer this work can be done while the vehicle is in for this UPDATE.
