Condition

This Update has been proactively released to adjust the vehicle departure deactivation and the electromechanical parking brake to the following functionality in the vehicle:

- Engine and ignition will no longer shut off when exiting the vehicle.
- If the engine is off (due to Start-Stop) when the door is opened, the ignition will shut off to prevent battery drain.
- The parking brake will not activate when the ignition is switched off. (A6/A7/S6 Only)

This Update is in effect until removed.

Vehicle must meet all of the following criteria:

- Procedure is valid only for vehicles that show the 97Y7 code in the ElsaWeb Campaign/Action Information screen on the day of repair.
- Vehicle must be in <u>New Vehicle Inventory</u>.
- Procedure must be performed within the allotted time frame stated in this Technical Service Bulletin.
- Procedure must be performed on applicable vehicles in dealer inventory prior to sale.

Technical Amendment: Switching the ignition/ engine off automatically*

The function described in the Owner's Manual in the chapter "On the road" is no longer valid.



Switching the ignition off automatically*

The following applies to vehicles with Start-Stop-System*:

To prevent the battery from draining, the ignition will switch off **automatically** when all of the following conditions have been met:

- The vehicle has already been driven.
- The engine has been turned off by the Start-Stop-System*.
- The driver's door is opened.
- The driver's seat belt is removed.
- The brake pedal is not pressed down.
- The vehicle is stationary.

In this case, the activated low beam will be replaced by the side marker lights. The side marker lights will switch off after approximately 30 minutes or when you lock the vehicle.

If the Start-Stop-System* has **not** turned off the engine, the ignition will **not** be automatically switched off and the engine will continue to run $\Rightarrow \Delta$.
