Only if a complaint is received or in the event of repairs: When installing the power-steering return line (970.347.23X.XX) on the cooler connection, always observe the following points:

- Irrespective of the existing setup (one or two clamps), two new clamps must be installed as follows:
- Use one new hose clamp ( $\Rightarrow$  Figure 1-item B-, 999.512.652.09) on the inside and
- also fit a second new hose clamp ( $\Rightarrow$  Figure 1-item A-, 999.512.489.00).
- Before installing the return line, clean the area close to the cooler connection (inner) using a clean, dry, lint-free cloth and fit it "dry".




