## **BULLETIN NOTE**

# APPLICABLE MODEL(S)/VINS

2007-2013 CX-9 vehicles with 4WD

## DESCRIPTION

Some vehicles may experience the front tire spinning and/or 4WD/DSC light flashes with no DTCs stored when driving uphill or taking off from a stop using hard acceleration.

Customers having this concern should have their vehicle repaired using the following repair procedure.

## REPAIR PROCEDURE

#### **WARNING:**

DO NOT turn on the engine during the procedure, people are near the drive wheels and the vehicle could fall off the hoist causing serious injury to people around the vehicle.

## NOTE:

- This procedure will require 3 people.
- 1. Verify customer concern:
  - a. With one person in the vehicle, safely raise and support the vehicle so all wheels are off the ground.
  - b. Turn the ignition switch to the ON position (ENGINE OFF).
  - Apply parking brake to prevent the rear wheels from rotating.
  - Shift the selector lever to drive (D) position.
  - e. Depress accelerator pedal fully to engage electronic control coupling.
  - f. While depressing and holding the accelerator pedal, have 2 people try rotating both front tires by hand in the same direction.
  - g. If both front tires can be rotated, confirm rear propeller shaft operation.
    - If the rear propeller shaft DOES NOT rotate, go to STEP 2.
    - If the rear propeller shaft DOES rotate, diagnose further and repair as necessary. Refer to Workshop Manual section 03 - DRIVELINE / AXLE.
- Replace the transfer unit. Refer to Workshop Manual section 03-16 TRANSFER REMOVAL / INSTALLA-TION.
- Verify repair.
